You can take responsibility by identifying and removing lead materials within your home plumbing and taking steps to reduce your family's risk. These violations do not usually mean that there was a problem with the water quality. If there had been, we would have notified you immediately. We missed reporting the sample result after the due date, or we did not complete a report/notice by the required date.
